


AGENCY FOR THE PROTECTION OF THE RIGHT OF FREE ACCESS TO PUBLIC INFORMATION

INFORMATION ACCORDING TO THE DRAFT MINUTES OF THE 121ST SESSION (JANUARY 24, 2023) OF THE GOVERNMENT OF THE REPUBLIC OF NORTH MACEDONIA



Skopje, July 2023

The Agency for the Protection of the Right to Free Access to Public Information, acting on the Extract from the Draft Minutes of the One Hundred and Twenty-First Session of the Government of the Republic of North Macedonia held on January 24, 2023, prepared Information which it submitted to the Office of the Deputy President of the Government, in charge of good governance policies, for implementing the Information to improve the transparency and accountability of public sector institutions by publishing the mandatory information according to the Law on Free Access to Public Information on the web sites of the institutions, as well as the publication of most frequently requested information systematized by area.

The Agency acting on the recommendation from the Conclusion (point 6) on July 5, 2023, to all **1501 holders** submitted an email in which he attached a Questionnaire, as well as the Draft Minutes of the 121st session of the Government of the Republic of North Macedonia. The questionnaire contained five questions to which the holders had to answer with YES/NO and move a link from the website on which they published the information according to the obligations, indications and recommendations contained in the draft minutes. The questionnaire to the holders contained the following questions:

- 1. Have you published the mandatory information from Article 10 of the Law on Free Access to Public Information on the website?
 - 2. Do you regularly update the published information monthly?
- 3. Have you published anonymously on the website the requests for access to information of a public nature for 2020, 2021, 2022 and 2023, together with the answers you have already provided to the requester so that they can be reused by other natural and legal persons without resubmitting a request with the same content?
- 4. Do you have a banner titled "Public Information" prominently placed on the website that leads to the public information (request and response after request)?
- 5. Have you published public information systematized by area, per Article 10 paragraph 1 point 22 "other information arising from the competence and work of the holder of the information" of the Law on Free Access to Public Information, as stated in The guideline for improving the transparency of public sector institutions?

The holders were given a deadline of July 21, 2023, to submit the answers to the questionnaires, that is, to fill them with the necessary data that was required of them according to the draft conclusion. They submitted completed questionnaires by the given deadline 437 holders, or 29,11% of the holders to whom it was delivered. This is a very small number of received data from which relevant data can be obtained on whether the institutions have complied with the obligations, indications and recommendations of the Government of the Republic of North Macedonia for their transparency and accountability for the publication of information in accordance with Article 10 of the Law on FAPI.

Until the deadline given for answering the Questionnaire from the received questionnaires, we can note that the holders who are indebted with this Information (items 1,2,3,4) **81** institutions answered the submitted questionnaire, which is **60,45**% of the total number of holders (**134**), and for these holders in this information, it can be determined how much their transparency and accountability has improved.

In the responses submitted by all institutions, **26** holders report that they do not have a website and hence at the time of reporting they are not able to inform about their transparency and accountability. Also, some of the holders report that during this period the data is being migrated to new websites or they are not active and hence they are not able to practice proactive transparency.

According to the received responses to the Questionnaire from the institutions, we are attaching the table with the summarized data:

NOTE:

Of the 5 questions of the questionnaire delivered to the holders of 437 answered questionnaires, the first question has the largest number of 307 affirmative answers with an attached link or 70.4%.

Out of 88 holders in this group, 35 municipalities and 3 of the development centers or 43.18% answered the questionnaire. Of the 38 questionnaires received with an attached link, 35 or 92.1% have received them.

Out of 354 holders in the group of public enterprises and public institutions, only 93 submitted an answer to the questionnaire or 26.2% of the total number. Of those 93 holders, 63 responded with an attached link or 72%

Holders from Other legal and natural persons exercising public powers and activities of public interest, which are a total of 72, of which only 21 holders or 29.1% answered the questions. All 21 holders or 100% answered the first question from the questionnaire.

Out of a total of 614 holders from educational institutions, only 146 or 23.77% answered the questionnaire. Of them, 87 or 59% answered affirmatively to the first question.

Out of 134 holders of state bodies, 81 institutions or 60.45% sent feedback. Of them, the largest number, ie 72 holders or 90%, gave an answer with an attached link.


The judicial authorities count 65 holders, of which 22 or 33.8% submitted a return questionnaire. However, 18 or 81.8% of those 22 holders answered the questionnaire in the affirmative.


The health institutions count 115 holders, but not a single institution submitted a responsive questionnaire.


There are 59 political parties as holders in the List of Holders, and only 10 or 16.9% of them submitted a questionnaire. Of the 10 submitted questionnaires, 7 or 70% responded with an attached link as an answer to the first question.




